### UPROAR AT COUNCIL'S PUBLIC MEETING

Basildon Council's Public Meeting on the Development of Billericay (including flats) held at the Archer Hall on Friday, degenerated into uproar several times during the evening. Labour Councillor, Mr.A.T.Dove of Basildon, was shouted off the platform.

The meeting was opened by the Chairman of Basildon Urban
District Council, Mrs.C.J.Gadson J.P, who referred to the recent
meeting held on the subject of Flats by Billericay Residents' Assn.,
and pointed out that the Council had only received two days' notice
of this meeting. She continued; "As the Council had only two days
to prepare the facts, I would question the value and effect of that
meeting, as the full story was not available. The memorandum
issued by the Residents' Association contains suggestions that are
baseless and that the Council utterly refutes. The Council could
have no possible purpose in covering up development unless national
security was involved. As for consultation with local organisations
the Council must bear in mind the standards of the respective

organisations" Cllr.A.F.Quirk, Chairman of the Development & Planning Cllr. Quirk stated that Billericay was in the Committee then spoke. Outer Country Ring, and from 1944 it had been proposed that Billericay should be urbanised, in 1949 Billericay was officialy named as an expanded town, and the 1957 County Development Plan specific areas for development in Billericay had been mentioned. Cllr.Quirk continued; "The 1971 population estimate has now been passed. Development has increased beyond that anticipated. The Minister has stated, that because of the pressure on land in Great Britain, there should be higher-density development and development of non-developed areas. The Council must play their part in the We have exercised our right under law national and County policy. to act as the Delegate of the County, and that right has been granted by law, and cannot be taken away unless the Minister of Housing & Local Government makes some change in the law. All proposed development is carefully considered, to see that it fits in with the Development Plan, and at the Planning Panel meetings, the members are advised by the Council's technical and legal advisers. Details of all planning applications are available at the Council Offices. We are only obliged to publish the plans in the case of some public building e.g. Skating Rink, Cinema, Theatre, Sewage Farm Otherwise the plans are the developer's copyright, and we cannot publish them without his permission".

Explaining the procedure of passing the Radford Way flats scheme Cllr. Quirk said; "Informal consultations took place between the Council and the developer in February/March, 1961, and the Planning Panel saw an informal sketch on the 3rd May. Before this the High Street Consultative Panel considered the scheme and I might gave their go-ahead. mention that this is composed of two architects and two C.P.R.E. members, and in this respect we are on of the most go-ahead Councils in the country, for I do not know of any other Council in the country which has such a Panel On the 29th May outline permission was given by the Planning Panel, the official decision being taken on the 16th June. On the 7th September detailed plans were. submitted, and final plans on 11th On the 18th October the advertisment was approved, and appeared on the 25th October. In In order that approval could be given within the required two months of plans being submitted, the Council had to name November 1st as the closing date for objections. As only one was received, the period was extended to 9th November. One more objection was received, and the plans were finally approved on the 16th November, for there was no significant public concern, and readers of "The Mayflower" (the Residents' magazine) and of the "Billericay Observer" knew of the plans in September. It is not true that Residents had only four days' notice, for they knew of the plans in September."

Referring to the Residents'
Assn. memorandum Cllr.Quirk said;
"Quite irresponsible statements
were made in the broadsheet.
They stated that the advertisment
in the "Billericay Times" was
inadequate as that paper only had
a circulation of 1,500; in fact
its audited circulation is 4,200.
(Some shouting from the floor).

Added Mrs.Gadson; "The proposed 1971 population was 16,700. It is now 18,500. In 1981 it is now proposed to be 24,000. In 1945 it was 7,000, in 1955, 8,500, and in 1960, 14,500. These figures are quite astronomical. The Council have received 794 planning applications, approved 476 and refused 348".

The meeting was then thrown open to the floor.

Mr.Ransome asked three questions. The first was; "Surely the 4,200 circulation figures for the 'Billericay Times, include Wickford? (loud applause)."

In reply Mrs. Gadson repeated the figures, and said that they were for Billericay alone.

Mr.Ransome then asked if the Council had no powers to publish the builder's plans. In reply Town Clerk Mr.A.Hatt said; "We have no powers to let the plans be inspected by the public, without the applicant's consent, except in the case of public buildings. Shouted Mr.Ransome; "That's no answer" (Loud applause, shouts of "Hear, hear!")

Mr.Ransome finally asked why the height had been increased from the original 5 to 7 stories (loud boos and shouting). In reply, Mr. Wadsworth, Engineer & Surveyor, said this was perfectly legal as long as the plan followed the outline application.

The Editors and Proprietors of the "Billericay Observer" wish to make it quite clear that the remarks reflecting upon the personal integrity of Councillor A.F.Quirk at a Public Meeting of the Billericay Residents' Association and reported in the issue of this newspaper for January 16th, 1962 in no way represent their opinion and are quite unjustified. They regret any distress that he has been caused.

Mr.Taylor then stated; "I am a member of the Consultative Panel. I and an Architect thought the plan that was before us was for a office block. Our view was 'It's a all right as a plan, but why have it there'. We never said it was a good plan" (At this the audience stamped their feet for some time, also loud cheering and loud applause). Commented Mrs. Gadson; "Stamping your feet won't get you anywhere".

The Planning Assistant to the Council said, in reply, that it was his job to place the plans before the Panel. As far as he could remember the general opinion was that it was a good plan.

Commented Mr. London; "Does the planning procedure justify the ends - look atvthe Industrial Estate. We have to live here, and not sufficent interest is paid to the views of local residents. Publicity is not given. It is an absolute shanbles (Shouts of "Hear!Hear!" and loud applause).

Commented Cllr. Quirk; "It is not fair to allege that the Planning is a shambles. You are here to stop development (shouts of "Hear!Hear!"). If there had been no population increase you wouldn't be here (applause).

Next speaker from the floor was Brian Edwards of Billericay Conservative Assn. who said; "There is a feeling in Billericay now 'Bless you old chap, I'm all right, keep out everybody else' We have a very small island, and we can't go building on the fields. (Mr. Edwards was interupted by angry shouts of "Keep to the point" "What's this got to do with the meeting", "Travel up 3rd class on the railways", to which he retorted "I do"). I think I think we are lucky to have a developer who will tackle such an uneconomical proposition".

Commented Mr. Horsey; "It's bad enough getting up and down by train as it is" (loud applause).

Replied Cllr. Quirk; "Of course it's difficult. The object of the Industrial Estate is to provide local employment. (Shouts of derision). Many artisans have found a job in these factories".

Stated Mr. Hillyard; "You are asking us to believe that 4 out of 5 houses in Billericay take the "Billericay Times". Audited circulation figures or not, I just can't accept that, 90% of local people work in London, and had five working days, to read the notice, get time off work, and go to Basildon and inspect the plans. If you think that is fair and sufficent notice I can't accept it. After various other speakers had made points, Mrs.Gadson announced her intention of letting Cllr.Dove, Labour Opposition Leader on the Council speak. Hillyard rose to his feet to speak and there were shouts of "Why shouldn't he speak?".

Continued Mr. Dove; "I agree that this is developing into an electioneering meeting (shouts of "Rubbish"), I am in complete agreement with the Conservatives on Flats. I am all for the Don't let's be toffee-nosed. I am all for them. (Stamping of feet, boos, shouts of "Go away", "Get off", "Throw him off", "Sit down", "You've missed the point," "Let Mr. Hillyard speak".

Appealed Cllr. Dove to Mrs. Gadson; "Tell Mr. Hillyard to sit down.
I'm speaking now". However, the
stamping and boos increased in volume, so Cllr. Dove threw up his hands in despair and walked off.

Mrs. Gadson summed up, and said that she would bring up the matter at the next Council Meeting of plans being available in Billericay. She then closed the meeting among shouts of "Let Mr. Hillyard speak"

### "THE PLOUGH" AT TYE COMMON.

(There is no "Billericay In 1765" article this week, as owing to the removal of 1,000,000 documents at the Essex Records Office, it has not been possible to obtain the document on which the articles are based. Instead, I am going to answer a question from Mr.Prow of Tye Common Road, who asks about the history of the derelict Public House at the corner of Tye Common Road and Frithwood Lahe, now being demolished).

The "Plough" (as the Public House was called) was erected sometime in the 1840's - in 1848 Edward Ager is mentioned in an Essex Directory as running the "Plough" Beerhouse at Tye Common. The building is a typical Early Victorian type. Tye Common actually existed at that time, and gave its name to the small hamlet of Great Burstead Parish, which was built around the Common. There would certainly have been some local demand for a "Beerhouse", but there could have been little through traffic, and the establishment was probably never a very profitable one.

According to the various Essex Directories, the landlords seemed to change once every few years! To state all their names would be monotonous, although these rapid changes further indicate that the "Plough" could never have been very profitable. However, by 1886 it had graduated from a "Beerhouse" to the status of a Public House.

The last landlord was Frederick Cowles. Sometime between 1926 and 1929, the licence was transferred to a new "Plough", which had been erected at Hutton, and still stands - the first landlord there was Arch. Wilson. I have been unable to definitely establish whether the licence was transferred because the "Plough" was losing money, and Hutton was growing, and a main road site would be profitable, or because the building itself was becoming dangerous, or a combination of both. - The Editor.

### ROUND AND ABOUT by "WANDERER".

Basildon Council are to be congratulated on calling the Development meeting. It is a pity that they didn't call it before the plans were finally passed.

Certainly, from the meeting, it is obvious that many local Residents feel very strongly about the town's development. They will have another chance to ask questions at the Public Forum at the Secondary School on Marchb 23rd - provided they give notice to the Clerk of the Council. I feel that the time is ripe for the Council to hold another Press Conference.

The flats may look very attractive on the model, but the model did not include their surroundings i.e. bungalow development in Cromwell Avenue and Stock Road.

Seeing the plan was of such great public interest, why did the Council not ask the developer if they publish outline details of the outline plan. The news of the proposed development was only revealed (in the "Billericay Observer" of August 29th, and subsequently in "The Mayflower") following an inquiry from a local resident.

At least a meeting with affected residents should have been held to explain the plan.

We were told at the meeting that one factory on the Industrial Estate employed 50 people, all from Billericay. How many of these people have moved into Billericay in the last six months? Why is there a minature "rush hour" every evening from the Industrial Estate to the Station?

As I have said many times before the effect of Industrial development on the commuter problem is very small indeed. The only development that will make any noticeable difference is large-scale office development.

I know that Mr.Hillyard had already spoken several times during the evening. But I consider that as he first raised the matter, and had a great deal of vital evidence, he should have been allowed to have a further say - and this seemed to be the opinion of those in the audience as well.
