FLATS PUBLIC INQUIRY — FULL REPORT

A Public Inquiry into the proposed erection of 70 single-bedroom flats in four or five storey blocks, and 47 garages, behind Chapel Street and Hillside Road, Billericay, lasted from 10.30 a.m. to 4.0 p.m. at the Old Council Chamber on Thursday, with only a short break for lunch.

The Apellant was Mr.V.A.Phillips of "Hawksley", Chapel Street, Billericay, and the Inspector was Mr.A.G.Harcourt A.R.I.C.S., M.T.P.I., Dip.T.P. It was stated at the beginning of the Inquiry that the site involved was 2.4 acres, and was next to a 16-flat development by Messrs. Crabbe in Chapel Street, which had already been approved. Permission had already been given to Mr.Phillips to build two houses on the Appeal site. The appeal was initially on account of the failure of Basildon Council to give a decision within the required two months, but had now become an appeal against the U.D.C. refusal for permission, after the appeal had been lodged.

For the Apellant, Mr.B.Edwards, Solicitor, pointed out that from 1945 to 1961 the approximate population of Billericay had grown from 6,000 to 18,000, and during that time development had been of semi-detached houses and bungalows, a low density development fashionable at the time. For the last six or seven years the U.D.C. had gradually become more appreciative of high density development, influenced much by the building up of the Basildon New Town. It was necessary to make the best use of the land available, and not to infringe on the Green Belt, and on land used for agricultural and rural purposes. It was also necessary to achieve a feeling of urban development in town centres, and that could not be achieved by semidetached houses and bungalows. Regard also had to be given to changing social conditions, which did not favour the large house and large garden.

There were certain advantages from the type of compact development proposed - there was a big saving on the provisio of all services and their maintenance. Most development now consisted of two/three bedroom houses, whereas in over half the households in the County there were no children, and 10 to 15% of dwellings had only one person. Billericay at present made practically no provision for the one-person household.

A scale model of the proposed development was produced, and it showed that the flats would be in a valley. The site, it was stated, was in close proximity to the town centre, and was in accordance with the publicly expressed views of the Minister of Housing & Local Government.

Mr. Edwards stated that if Chapel Street was to become a main road, he accepted the difficulty of access, but alternative ways of access could be considered, as for example, by sharing access with the Crabbe site, or by access to the Chantry Estate.

He added that the development would be of the very highest quality, and the developer, a local resident, was most anxious to preserve all the surrounding amenities; the overlooking of Hillside Road being avoided by the

siting of windows.

Mr.R.Park, Architect, gave similar and more detailed evidence for the Appelant. In reply to Mr. Hughes (Assistant Clerk to Basildon Council) he stated that in his view the value of surrounding properties would be increased, as on account of this high density development the value of surrounding land would increase. Apellant was the question of access.

For the U.D.C., Mr. Hughes
stated that the U.D.C. objection was based on the question of access to Chapel Street. This might become a relief road to the High Street, under a scheme for traffic to proceed from Laindon Road, along Sun Street, along part of Chapel Street, and behind the Ritz Cinema to join up with Stock Road or Norsey Road, or might become part of a one-way traffic scheme. In fact, their objection held good whichever scheme was adopted, as either scheme would involve widening parts of Chapel Street by about 50 feet.

Mr. Power said that the Association had no official policy regarding Flats, and that the objections were not raised just because the development involved Flats. They were aware of the problems that had arisen from the rising birth rate, and the desire of more people to have a home of their own, but they were also aware of the problems that high-density development caused in the town, and they had to bear both sets of problems in mind. From what he had heard and seen at the Inquiry he had no alternative butvto withdraw the objection of lack of harmony with the syrrounding area, and the objection that the educational services would be further strained. But the other objections remained. He felt that with the type of person likely to occupy these flats, the garage accommodation would be inadequate.

In reply Mr. Edwards said that he could not deal with the question of pressure in services, but in addition to the garages there would be twenty-nine garage spaces. He stressed that the only difference between the apellant and the U.D.C. was the question of access.

One private resident (Mr. Hopkins) gave evidence. Mr. Reeve, (Basildon Council's Chief Planning Officer), Mr. Phillips (County Council Planning Office) and Mr. Taylor (Billericay C.P.R.E.) were present in an observatory capacity.

After the Inquiry the Inspector inspected the site. result of the Inquiry will be published in the "Billericay The Observer" in due course.

GATWICK ESTATE TO BE MADE GREEN BELT.

FUTURE OF BILLERICAY NOT ROSY SAYS C.P.R.E. SECRETARY.

The future of Billericay is not as rosy as it should be, states Mr.W.Taylor, Secretary of Billericay Council for the Preservation of Rural England in his Annual Report to be presented to the forthcoming A.G.M.

Mr. Taylor reviews the work of the Group in the year (including membership of the High Street Consultative Panel, provision of a Bus Shelter at Perry Green, preservation of trees, and the signposting of footpaths) organisations took an interest, not and refers to "callous indifference" by developers and others with "The tree regard to trees. 

BILLERICAY IN 1765.

In 1765 Billericay had fourteen Inns (or Public Houses) in the High Street area, and two in the country - an all-time record. In the town were the "Three Horseshoes", "Red Lyon", "Hare & Hounds", "White Lyon", "White Hart", "Swan", "Fox", "Bull", "Bull Kitchin", "Chequers", "George", "Kings Arms", "Kings Head", and the "Crown", while in the country were the "Bell" and the "White Horse".

The "Red Lyon" at this time was owned by Samuel Wall, and occupied by Abrm. Thresher, one of the last members of the great Thresher family of Billericay. The "Red Lyon" was one of the most prosperous Inns in the town, and a Tradesmans' Token issued by Abrm. Thresher (a halfpenny) showing a Fleur de Lys as his sign is still in

Thresher (a halfpenny) showing a Fleur de Lys as his sign is still in existence.

The "Three Horseshoes" was in the Manor of Cowbridge, and occupied the present "Three Horseshoes House". It came into being sometime between 1738 and 1765, and continued trading until the present The old inn sign bracket still hangs from the front wall century. of the house.

Little is known of the "Hare & Hounds" mentioned in the 1765 rental, occupied by Weston Cokeham. It was probably on or near the site of the County Library.

The "White Lyon" was on the site of Shelley's, and was one of the

more established and prosperous inns.

The "White Hart" is recorded as on the site of the present Barclays Bank. However, in another part of the rental, an entry is crossed out, and the "White Hart" inserted. This indicates that the move from the Barclays Bank site to the present one near the Post

Office took place around this time, Richard Wingford is still shown as the owner of the "Swan" (site of Stanleys the Butchers). He is first mentioned as owning this property in 1706, and it is probable that shortly after 1765 he died, and the Inn with him. The "Fox" was somewhere between Norsey Road and the "Bull". The "Fox" started at the High Street/Stock Road/ Norsey Road junction in 1647, when it was the first local property to be acquired by the Thresher family, and ended its wanderings at the end of the 19th century as a Beerhouse on the site of the Co-op.

The "Bull" and "Bull Kitchin" were old established Inns around the site of "Speeds Cafe". The "Chequers" was opened on its the site of "Speeds Cafe". The "Chequers" was opened on its present site between 1738 and 1765, the Owner/Occupier in 1765 being Sarah Peacock. The "George" was on the site of Howards, and the "Kings Arms" on Laylands. "The Kings Head" was adjacent to the "Kings Arms" in 1765, but beyond that nothing is known of its history. The Crown Arch and Mard still exist today, and the "Crown" was one of Billericay's most prosperous Inns - the collecting point for the town's first postal service. The "Bell" was at the bottom of Bell Hill, and nothing is known of the "White Horse" in Coxes Farm Rd,




